Rev. Victor King, Director

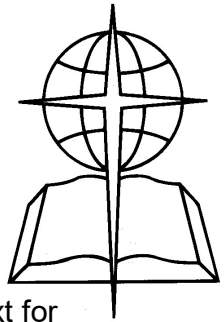

We completed the **Winter Session** with a study in the book of "**Romans**," using F. F. Bruce's *Tyndale New Testament Commentary: Romans*. In this study, the writer tries to put Paul's thoughts in a language that can be more easily understood today. The basic objective was to gain an understanding of Paul's exposition of Salvation by Faith.

In the **Spring/Summer Session**, we completed a study of the book of "**Galatians**," using R. Alan Cole's *Tyndale New Testament Commentary: Galatians*. This study was an exposition of the major truths of Paul's letter to the church at Galatia.

In the **Fall Session**, we completed the study of "**The Bivocational Pastor**," using Luther M. Dorr's, *The Bivocational Pastor*, and Doran C. McCarty's, *Meeting the Challenge of the Bivocational Ministry: The Bivocational Reader*. This study was an overview of bivocational ministry, including its biblical and historical roots, trends affecting the development of bivocationalism, the unique nature of bivocational ministry, preparation for the work of the bivocational minister, the specific duties of ministers who serve bivocationally, and the future of bivocationalism.

Greetings to our McMinn-Meigs Baptists from Christian Builders. In our report to you for the past year, we have built 15 ramps and did 14 grab bar or handrail jobs. We do get some grants for materials when clients qualify, and we pay for grab bars and hand rails from our monies we get from donations.

We have also assisted a couple of churches with design and supervision for some ramp jobs they have done for people in Meigs County. The churches provided the materials. We were pleased to help.

This year's challenge was still the COVID. With the addition of our new generator, we do not have to enter someone's home to get electricity for our tools, which is a big help.

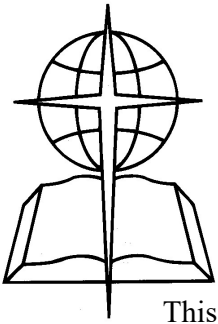
We did have a hiccup this year. Someone decided they wanted our tools more than we did, and broke into the trailer and stole the more expensive tools, including our generator and air compressor. We are covered under the Baptist Office insurance, and with the gifts of some churches and individuals, we were able to cover the deductible, and even upgrade some of our most used tools. And, we bought some high security locks for the trailer. Oh, and we were given a set of bolt cutters courtesy of the thieves.

I still want to challenge our churches to give \$100 each per year to Christian Builders. Many are giving the \$100, and some have given more. We also accept donations from individuals.

This year, as last, we have seen several clients opt to pay for their materials. Sometimes clients can afford the materials, but not afford the labor to build a ramp. We still build these ramps free of charge for the labor we do. We have been blessed that some also gave a gift to Christian Builders.

We can always use more volunteers. If you can carry a board, we can use you. If you know how to run a saw or nail gun, we can use you. If you have a PhD (post hole digger degree) we can use you!

Lastly, please keep all of our clients, past, current and future in your prayers. Many times as I go to interview these people, they are dealing with medical issues, in pain, and depressed. Some tell me they used to go to church, but now due to their disability, they can't. And, they feel like their church forgot them. They need our churches to reach out to them. They are your neighbors.

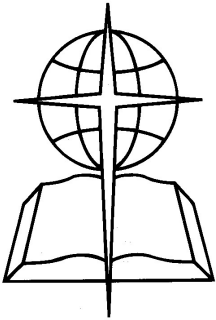
Personnel Committee Report:

Christian Builders Report:

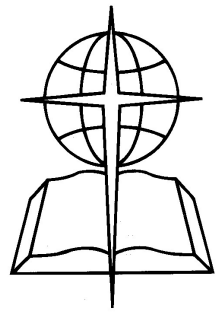

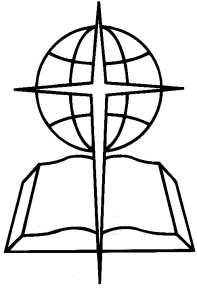
Registration of Messengers: we have 95 messengers representing 33 churches present this evening.

Rev. Mike Farmer, Director of Missions presented his report.

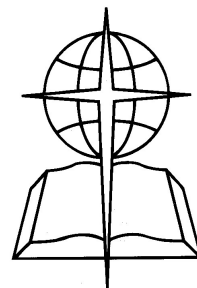
Welcomed everyone who was able to attend tonight – since it has been two years since we have had an annual meeting.

Highlights of the Foundation's stewardship thus far for this fiscal year include:

- **Funds under management: Over 1,100**
- **Assets under management: \$178,965,513 (as of June 30, 2021)**
- **New fund additions as of June 30, 2021: \$998,838(12 new funds)**
- **Educational scholarships: 164 - totaling \$175,100 for 2021-2021 academic year. (Awarded over \$5.8 million in scholarships since 1987)**
- **Special Project Grants: As of June 30, we have distributed \$35,400 to assist 8 ministry projects.**
- **Cooperative Program: \$442,575 as of June 30, 2021. Projected to give over \$600,000 by year end.**
- **Baptist and charitable causes: \$2,197,080 as of June 30, 2021. Projected to give over \$3.3 million by year end.**

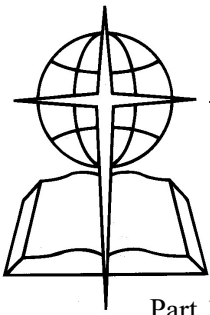
Though I wish that I could report to you that we did not experience any cases of Covid-19 in our homes, I cannot do that. I can, however, report that we had only a few infections and we have been successful in limiting any wider spread. That is because of the faithful men and women who serve as direct care providers in our six group homes. As always, I remain grateful and appreciative for their diligence and vigilance as they joyfully "*Show What Love Is.*"

We were able to get our residents vaccinated very early (January) due to them being a part of a priority group. Because we've been vaccinated, we are again able to conduct placement interviews. We are hopeful to fill our vacant group home beds over the coming months.

I mentioned in last year's report that the proceeds from the sale of Williams Ferry Pointe in Lenoir City were going to be used to help us realize a **two-fold vision** to...

1. Establish a significant endowment that will produce operating income. Our Father's Day Offering has never managed to rise to a level to offset our operating deficit.
2. Establish a small senior living community in Humboldt on land we already own where we can provide modest, comfortable retirement living (probably duplexes) for financially needy seniors, with priority given to indigent pastors and missionaries. TBAH will own these facilities and rent them on a sliding scale basis. They will be for independent living seniors; we will provide no health care or physical assistance. The Humboldt project will be a TBAH ministry in west Tennessee!!

Part 1 of our vision has been realized through the establishment of the SOAR fund (Supplying Ongoing Aid to Residents) through the Tennessee Baptist Foundation. The SOAR fund is now growing interest that will be used to help offset our operating deficits. Part 2 of the vision will have broken ground and at least one duplex unit will be nearly complete by the time of the Summit!

Finally, I am sad to report that we had to cancel Special Friends Camp for the second year in a row due to our inability to find vaccinated Counselors. We were able to provide an online “virtual camp” experience with live ZOOM sessions and pre-recorded videos and activities during the week that would have been SFC at Camp Linden. We have every intention of returning to SFC in 2022 and will be using this year to make some major changes to the format and organization of camp so that we will come back fresh and improved.

TENNESSEE BAPTIST CHILDREN’S HOMES

2021 marks the 130th year that Tennessee Baptist Children’s Homes has been welcoming children in hard places with the love of Christ. We are only able to welcome these children into our homes because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling. Thank you for your prayers, for your service and for sharing your financial resources with TBCH. We are committed as a ministry to operate without the use of government funds relying on God’s people to supply the resources necessary to meet the needs of the children and families we serve.

The Lord has once again shown His faithfulness to this ministry by providing the necessary resources for us to care for 220 children during the first nine months of our fiscal year. **Five** of these children have been born again! Rest assured that TBCH is Christ centered in our approach to dealing with children and their families. We believe Jesus is the ultimate answer to all brokenness and our team unashamedly points people to Him in age-appropriate ways.

TBCH has provided **Residential Care** for 77 children since November 1, 2021, in our on-campus homes. Fourteen of these children have been successfully reunited with their families. TBCH is also committed to assisting those who age out of our program. These 18+ year-old **Independent Living** residents on our Chattanooga Campus receive continued support by our staff and learn a trade or attend college. We are committed to helping these young people get off to a good start in early adulthood. There are presently seven young people in our Independent Living program.

TBCH’s **George Shinn Foster Care** program has served 143 children since November 2021 and has 74 foster homes on our team. Twenty-five children have been adopted into Christian families while 12 children are presently in foster-to-adopt situations!

Our foster home in **Oakdale** and our most recent newly opened home in **Kingsport** have the capacity to welcome large sibling groups of foster children. These two homes are both manned by families who sense a calling to care for vulnerable children and I am thankful for their willingness to help us serve children. TBCH is grateful for the churches and volunteers who are helping these ministry locations thrive!

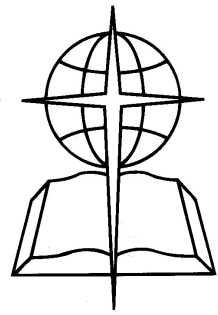
TBCH’s **Family Care** program stands ready to provide training for your church in child abuse awareness and prevention. **Stewards of Children** is a sexual abuse awareness training provided by Darkness to Light which is a non-profit committed to empowering adults to prevent child sexual abuse. This is a two-hour video-based curriculum containing the heroic stories of sexual abuse survivors. These testimonies are coupled with professionals and counselors who provide guidance for individuals and churches when it comes to raising awareness and preventing abuse in your church and community. TBCH has six staff members certified to lead **Stewards** in your church or virtually! Ninety-one individuals have been trained in **Stewards** this year. .In 2021-21, Tennessee WMU challenged Tennessee Baptists to be relentless in living authentic faith in Christ, seeking God in prayer, giving sacrificially, and witnessing to others. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Due to staff transitions and the pandemic, many events were cancelled, some shifted to an online version, and new opportunities were developed

A BEST OF JAM Kit was compiled with some of the favorite JAM activities and lessons from past years and was made available for churches, groups, or families to use with their children.

Virtual Get-Together & Connection was held online on March 20, , with content being available to registrants to view on demand through June 30, . Of the 559 people who registered, at least 444 viewed the online content and they represent over 175 churches. Tennessee Baptist Children's Home received this year's ministry project gifts through an Amazon Wishlist.

As part of Tennessee WMU's Denver prayer advocacy partnership, Virtual Denver Prayer Tours were held from October 2021-August . Each virtual session introduced church planters and allowed participants to pray for them and their families.

Holding the Ropes: Devotions and Praying for Missionaries video series was shown on the Tennessee WMU Facebook pages and groups in late 2021. These daily devotions and prayer times for missionaries were led by older missions-minded youth, young women involved in WMU and missions, WMU Scholarship recipients, and IMB missionaries from Tennessee.

3 Circles Evangelism training video with supporting materials targeted for youth groups was produced and distributed.

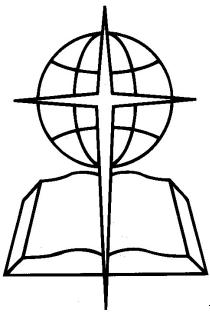
Zoom with a Missionary online meetings were hosted allowing missionaries to interact with children/youth missions discipleship groups. There were children's groups from 25 churches who met missionaries from North Africa, Philippines, Italy, Thailand, Spain, Japan, China, North Africa, Venezuela, and from the United States – Colorado, Louisiana, and Ohio.

Tennessee WMU joined Sisters Who Care Chattanooga as they hosted a multi-state/regional meeting via Zoom on March 26-28 with over 80 in attendance. Sisters Who Care is the African American expression of Women on Mission.

Covid restrictions opened up for Tennessee WMU to be able to host a very scaled back Annual Meeting on May 1, , at First Baptist Church, Cookeville. Highlights from the meeting were reports of the work of Tennessee WMU in the past year, the approval of recommended Bylaw revisions and the election of the -22 Tennessee WMU Officers & Regional Promotion Directors.

Checks for \$150 were sent to 20 missionary kids whose parents serve with IMB and are from Tennessee.

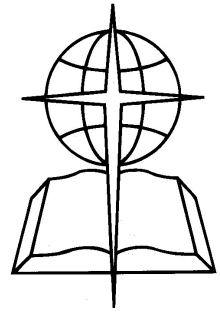
Checks for \$50 were sent to 94 retired IMB missionaries who were born in Tennessee.

Missionary Houses in Mt. Juliet – Mary's House (WMU House) and the Missions Mobilization Center (MMC) House continue to be a hub of activity as they provide a place for our missionaries to rest and reconnect with family and friends. The Worthy family arrived at Mary's House in June 2021 and have extended their stay through February 2022. After staying at the MMC Missions House for a year, Frank & Sheri Moran moved out on April 30, . Jason & Jennifer Vanover moved into the MMC Missions House on May 20, and will be staying through January 31, 2022.

In April , \$35,275 in scholarships were awarded to 34 students attending graduate school, seminary, as well as undergraduate schools in Tennessee during the -22 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

The theme for the 2021-21 Tennessee Missions Emphasis was "See and Tell Tennessee." The suggested dates for the Week of Prayer for State Missions were September 13-20, and the goal for the 2021-21 Golden Offering for Tennessee Missions was \$1,800,000. The total amount given as of July 27, , was \$1,686,665, The offering year goes from September 1 – August 31.

BAPTIST MEMORIAL HEALTH CARE SYSTEM MEMPHIS, TENNESSEE

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough – at one point, it almost closed – but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way.

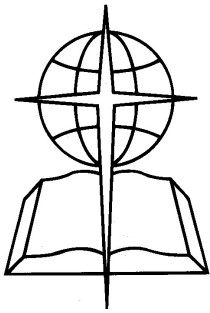
The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines.

Because of the COVID pandemic, we had to pause the Rev. Jimmy Terry Preaching Series events – where each month, a speaker delivers an evangelical message at our flagship hospital –but we resumed it in July 2021 with limited in-person seating and an emphasis on virtual attendance. Since the beginning of this year, we've been gradually moving toward having more in-person attendance. Thousands of people virtually attended the sermons, and videos of the messages have been viewed 86,800 times on Facebook.

Baptist continued to be the Memphis area's source of truth and accuracy about COVID-19. To date, we have earned 74% of the COVID-19 news coverage, and Baptist's experts were interviewed for almost 1,000 print and TV news stories on national and local news outlets.

We are planning to break ground on our first freestanding emergency department (FSED) in September. Located in Arlington, Tennessee, a Memphis suburb, it will serve a four-county area that includes two communities that lost hospitals and don't have convenient access to emergency care. Today, many patients in these areas travel up to an hour to come to Baptist Memphis. The new FSED would cut that commute in half. The FSED will have eight rooms, a CT scan, X-ray, ultrasound imaging and a helipad. We'll also bring more than 30 high-wage, professional positions to the community.



HARRISON-CHILHOWEE BAPTIST ACADEMY DBA THE KING'S ACADEMY

Harrison-Chilhowee Baptist Academy celebrates 142 years as a distinctively Christian school, serving East Tennessee and the World. For the past 28 years, Tennessee Baptist's accredited Christian boarding and day school has operated as The King's Academy. International students are the academy's most distinctive feature—over 1,050 students from 99 nations have enrolled since 1935; an average of 14 countries are represented in the academy student body each year.

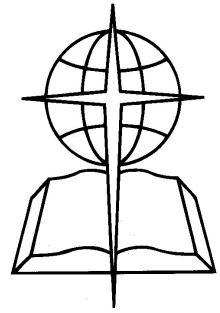
The academy remains focused on its VISION – *Transformed Lives, Empowered by Christ-like Character, Pursuing Academic Excellence and Lifelong Service* – and committed to its MISSION: *The King's Academy inspires and equips students of all cultural backgrounds to fulfill their God-given potential in a nurturing, college preparatory community.*

The academy continues to face challenges on the heels of the global pandemic, with the majority of operations shifting back to a new sense of normalcy and a return to on-campus learning and activities. Enrollment for the upcoming school year (-22) has eclipsed the previous year's numbers, and projections place the student body near the enrollment levels prior to the Covid-19 pandemic. Moving forward, the academy must balance the socio-economic demographics of academy families to remain financially feasible for both local and international students in order to remain a viable partner for faith-based education.

TKA welcomed Jeremy Sandefur as the new President/Headmaster for the -2022 school year and is excitedly looking to the future. While the heritage of TKA is rich and deep, the days ahead are bright as the new administration focuses on developing servant leaders who will change the world for Christ. Through focusing on service leadership, TKA desires to reach the surrounding communities while providing a biblically based approach to curriculum and service instruction.

The newly formed "Love Where We Live" initiative will place TKA students in strategic partnerships throughout the communities of East Tennessee in order to serve and to learn more about the Lord through service. Day and Boarding students will participate in grade level mission projects to develop a deeper understanding of God's creation and to inspire a culture of service. TKA will seek to continue to be the choice for a Christ-centered, academically challenging education while fulfilling the Great Commandment of making disciples of all nations.

It is a distinct privilege for the academy family to partner with and serve alongside Tennessee Baptists in the mission of Christian education.

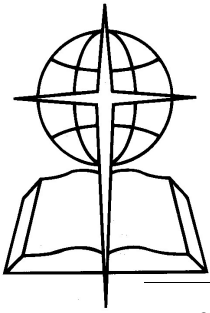

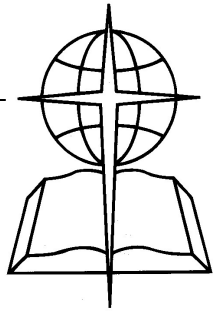

Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders.

This past year has included:

- Carson-Newman's Board of Trustees approved a five-year strategic plan entitled "Acorns to Oaks: Pursuing God's Preferred Future." The strategy calls for new academic buildings, expanded athletic offerings, new and renovated facilities, enrollment growth and greater missional alignment. The plan culminates in 2026, which marks the 175th anniversary of C-N's founding.
- In July, Carson-Newman launched the first project from the new strategic plan: breaking ground on the Drama and Ted Russell Center. The new 48,000 square-foot health sciences building will be home to C-N's Nursing Department. The three-story building is slated for completion in 2023.
- At the opening of the 2021-21 academic year, the University announced a record enrollment of 2,911 students. This marked two years in a row C-N celebrated an enrollment record. It also welcomed a record number of graduate students (1,189). The school later celebrated a record spring enrollment of 2,729.
- The University was featured by U.S. News & World Report, which ranked C-N in the top 10 in the state overall and second in Tennessee for social mobility. It also named C-N's online graduate education program No.1 in the state. The University was touted as the state's highest-ranked private school in the "Best Online MBA Program" category.
- In recognition of a lifetime of service by alumni and missionaries Dr. Bill and Linda Viel, C-N named its campus ministries building in their honor and renewed its focus on Gospel sharing and Gospel living.
- In the fall, the University hosted the Gospel Saturated Life Conference featuring Dr. Wade Akins of Pioneer Missions Global as its speaker. Students heard the power of missions from Akins who has served as an evangelist, missionary and trainer of church planters in

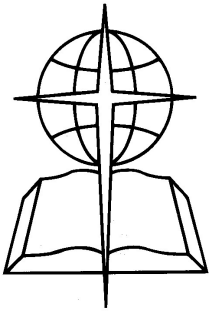

What is a Baptist Association?

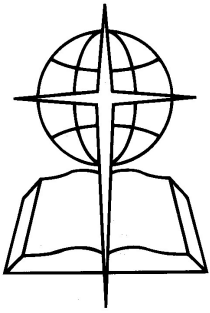
(An Association is what the churches make it.)

A Baptist Association is a self-governing fellowship of autonomous churches sharing a common faith and active on mission in their setting.

1. The churches of an association are free, independent, self-governing, autonomous churches that decide to associate themselves to do certain things together.
2. The fellowship of churches involves oneness, shared life, mutuality and koinonia. It is a “family” of churches and a network, in which churches give and receive assistance. The association as a fellowship emphasizes the relationship existing among the churches.
3. Sharing a common faith - The fellowship of an association is grounded in harmony in faith and practice. Associations differ in regard to the particular doctrinal issues that are important to their fellowship and in regard to the amount of diversity encouraged or tolerated on those issues. Nevertheless, the association, unlike state conventions, is a doctrinally based fellowship.
4. Active on mission refers to God’s mission for the churches individually and the churches together in association. The first responsibility of each church is to deal with the same question, “What is God’s mission for us together?”
5. In their setting deals with everything anyone means when he or she says of his or her association, “But I am in a peculiar situation.” Every situation is peculiar, that is, unique; and it is in the uniqueness of that situation that an association of churches has a very special responsibility to be on mission. Associations differ from one another in such ways as size; geographical territory; population; cultural, ethnic, religious, socioeconomic and demographic characteristics of the area; number, strength and types of churches; history; relationship to the state convention; and stage of development.
6. Self-governing - An association is created by the churches and is accountable to those churches through the messengers. An association, like other general bodies of Baptists, (state conventions, Southern Baptist Convention), is self-governing.

A Baptist Association is what the affiliated churches decide to make it. The messengers and executive board members selected by the churches make those basic decisions. The churches decide again what their association will become when they decide what percentage of their church budgets will go to associational missions.

Southern Baptists are committed to Bold Mission Thrust in a general way. You can be a part of what’s happening in a specific way through involvement in your church and association.

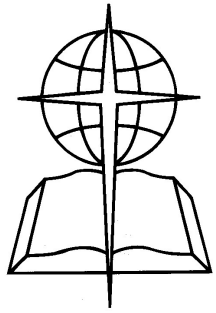
**McMinn-Meigs Association of Baptists,
Incorporated**
BY-LAWS

Article I – Existence, Purpose and Relationship

- Section 1:** The McMinn-Meigs Association of Baptists, Inc. exists because Southern Baptist Churches have chosen to join together in fellowship, evangelism and missions.
- Section 2:** The purpose of the McMinn-Meigs Association of Baptists, Inc. is to equip, resource and encourage one another to be faithful Kingdom Servants in obedience to our Lord's Great Commission.
- Section 3:** The McMinn-Meigs Association of Baptists, Inc. shall maintain a cooperative relationship with the Tennessee Baptist Convention and the Southern Baptist Convention in a world mission program.

Article II - Voting Body

- Section 1:** This Association in session shall be composed of messengers duly elected by the Southern Baptist Churches in McMinn and Meigs Counties who are affiliated with this organization. The affiliated churches shall be those that choose or elect to cooperate with the principles and practices of the Association as set out in the Charter of Incorporation and as herein set out.
- Section 2:** Each church shall be entitled to two messengers and one additional messenger for each fifty members or fraction thereof after the first hundred with a maximum of ten messengers from any one church.
- Section 3:** Any church petitioning for membership in the Association shall make such petition through the Credentials Committee. Each church whose petition is approved by the Association shall then be placed under the watch care of the Association for one full year or until the next annual session of the Association. At that time, and providing the church has proven to be in sympathy and in accord with the tenets and practices of the Association, it shall then, by a majority vote of the association messengers present and voting, become a member in full standing. During the year of watch care, the petitioning church shall have a voice but not a vote in Associational affairs, including the representation on the Executive Committee and messengers to the Association.
- Section 4:** As a condition of membership in the Association, member churches shall subscribe to the Articles of Faith as outlined in Article III. In addition, member churches are strongly encouraged to submit an annual church letter that will provide demographic information on the ministry and health of the church and contribute to the financial support of the Association.

A. Articles of Faith

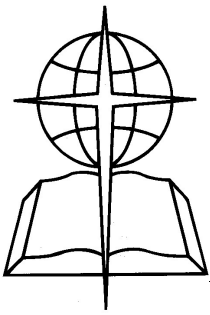
- 1) If any member of the Executive Committee feels that an affiliated church is in violation of any section of the Articles of Faith, said member should follow the guidelines of Matthew 18:15-17.
- 2) Should members of the Executive Committee, representing a minimum of two affiliated churches, believe that an affiliated church is in violation of the Articles of Faith, said members, after having, individually, followed the provisions of sub-Paragraph a of this Paragraph, shall bring the violation to the attention of the Association Officers. The Association Officers shall direct the Credentials Committee to investigate the charges brought against the member church, following these guidelines:
 - a) The Credentials Committee shall contact the church charged with a violation of the Articles of Faith in an effort to confirm the validity of the charges brought against the member church.
 - b) Should the Credentials Committee confirm the validity of the charges, every effort shall be made to lead the church back into conformance with the Articles of Faith and restore the church to fellowship with the Association.
 - c) Should the efforts of the Credentials Committee outlined herein fail to resolve the issue, the Committee shall present a report along with recommendations concerning membership to the Association at the next annual meeting or a special called meeting of the Association called for the expressed purpose of dealing with this issue. No such action shall be taken without at least 14 days written notice to all affiliated churches.
 - d) A recommendation for the loss of membership from the Credentials Committee shall require a two-thirds majority vote of the messengers present and voting at the meeting in which said recommendation is presented.

B. Re-admission

Any church dropped from the rolls, as a result of Section 4, may thereafter petition for re-admission under all the terms and conditions herein above prescribed for admission of churches to membership.

Section 5:

If any member of the Executive Committee feels that fellowship should be withdrawn from any affiliated church for any reason not listed above, said member should follow the guidelines of Matthew 18:15-17. If it is, thereafter, deemed necessary, by the Association Officers, to withdraw fellowship from any church FOR ANY REASON OTHER THAN THOSE SPECIFIED IN SECTION 4, and to refuse to seat its messengers, such action shall be only by a two-thirds majority vote of those messengers present and voting at any annual meeting or special called meeting of the Association called for this expressed purpose, exclusive of the messengers from the said church. No such action shall be taken without at least 14 days written notice to all affiliated churches.

Article III -Articles of Faith

The currently adopted Southern Baptist Convention version of the Baptist Faith and Message shall be the doctrines adopted by this Association.

Article IV - Authority

Section 1: The Association is an autonomous body and therefore reserves the right to determine its own policies and direct its own business; it may refuse to seat messengers who are not in fellowship or doctrinal agreement with the body or if the church by whom they are elected is not.

Section 2: The Association may advise, give counsel, and propose measures to the churches, but shall exercise no power or ecclesiastical jurisdiction over the churches. It shall have power, however, to withdraw fellowship from any church that departs from the doctrines and practices of Baptist Fellowship in accordance with the guidelines of Article II, Section 4.

Section 3: A church shall be considered a Southern Baptist Church in good fellowship with the Association if said church accepts and follows the Baptist Faith and Message referenced in Article III hereof as well as the conditions identified in Section 2 of this Article.

Section 4: Any question concerning fellowship with the churches shall be referred to the Credentials Committee for review in accordance with Article II, Section 4 (A) before presentation to the Association.

Article V – Meetings

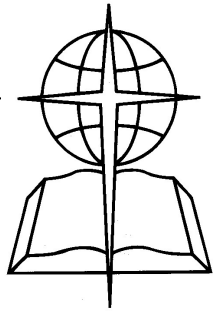
Section 1: The Association shall convene annually in the Fall for the annual business session, unless otherwise fixed by the Association in annual session. The Association may also come together in the spring for an Association Celebration emphasizing Evangelism and Missions in one special event.

Section 2: Special Meetings: The Executive Committee of the Association may call the Association into special session at a time and place set by the committee, with the provision that all affiliated churches must be notified in writing at least 14 days before the special meeting, said notice to give the time, place, and purpose of the meeting.

Section 3: The program for all Meetings shall be planned by the DOM and Association officers with the assistance of an ad hoc committee as necessary.

Article VI - Associational Year

The Associational year shall begin on October first and end on September thirtieth.

Article VII – Officers

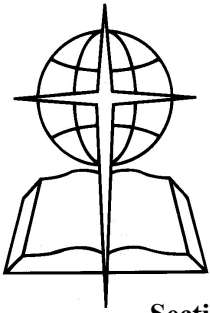
Section 1: The officers of this Association shall be a moderator, an associate moderator, a clerk, a treasurer, and such other officers as may be authorized by the Association. The moderator of the Association shall have the same duties as the president of a corporation is generally understood to have. The moderator and the associate moderator shall not serve for more than one consecutive year, and provided further, that no person shall be eligible for election as moderator until he shall have been a member of the Association for a period of two years. Furthermore, one of the offices, moderator or associate moderator, must be filled by a bi-vocational minister or a layperson. The retiring associate moderator shall be eligible for election to the officer of moderator. The clerk and the treasurer shall be employees of the Association.

Section 2: The officers shall be elected at the annual meeting by majority vote of messengers present and voting, and shall take office at the close of the annual meeting. They shall serve until the close of the next annual meeting of the Association, or until their successors are elected and installed, provided, however, that the retiring clerk shall continue in office as association clerk until the completion and publication of the Associational Minutes and completion of any other duties connected with his/her office for the past associational year.

Article VIII - Executive Committee

Section 1: There shall be an Executive Committee of the Association which shall consist of the following: one lay member elected by each church of the Association from its membership; the Director of Missions, director or chairman of all organizations and committees authorized by the Association; and the pastors of all churches in the Association. The moderator, associate moderator, clerk and treasurer shall be ex-officio members of the Executive Committee. The Executive Committee shall meet quarterly at the Baptist Center, 350 North Congress Parkway, Athens, Tennessee, or at such other place as may be previously determined. The Annual meeting will serve as the meeting for the fourth quarter of the year of the Executive Committee. The Executive Committee shall also meet at the call of its chairman. Twenty members of the Committee representing a minimum of 10 member churches shall constitute a quorum necessary to transact business. At its third quarter meeting preceding the Annual Session of the Association, the Executive Committee shall select the director of all organizations which may be authorized by the Association and as nominated by the Nominating Committee. The organizational directors so selected shall take office immediately following the next annual session. However, following the selection by the Executive Committee, the newly selected organizational directors shall be asked to recommend, to the Committee on Committees, the members for their respective committee/organization for the ensuing year.

Section 2: The pastor of any church organized as a result of a mission operated for not less than two years under the sponsorship of a church affiliated with the Association shall be a special member of the Executive Committee, with voice but no vote, until such times as said church shall have an opportunity to apply for and become affiliated with the Association.

Section 3: The officers of the Association are to be the officers of the Executive Committee, with the moderator of the association serving as chairman. The officers of the Executive Committee shall meet to plan the agenda for each Executive Committee Meeting. This meeting shall occur with sufficient time to notify the members of the Executive Committee of the pending business for the upcoming meeting.

Section 4: The purpose of this Committee shall be to care for every interest of the Association and direct its activities in the interim between the annual meetings and shall carry out the policies and will of the Association as so expressed. The Committee shall have power to fill vacancies, as nominated by the Nominating Committee, among the officers of the Association and the Board of Directors or committees which may occur during the year except representatives to the Executive Committee and may authorize the appointment of any special committee deemed needful to carry out its duties.

Section 5: Nothing outside of or beyond the authority given by the Association to the Executive Committee shall be exercised, unless prior written notice of at least thirty days has been given all of the churches of the Association and the members of the Executive Committee, with the opportunity for any member to present his views to the vote of the Committee.

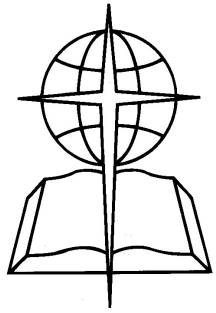
Article IX - Board of Directors

Section 1: The Association shall have a Board of Directors composed of nine members. Six members are to be elected at the annual meeting and serve, along with the moderator, associate moderator and the treasurer, as the Board of Directors. The Director of Missions shall serve as an ex-officio member. The (six) directors are to be elected on a rotating basis, as provided in section 3 of this article.

Section 2: The members of the Board of Directors must be members of churches within the Association, in good standing, and recognized for their knowledge and their loyalty to the programs of the Association.

Section 3: The members of the Board of Directors shall be elected on a rotating basis, provided that in no case shall any person serve on the board longer than three years in succession. The first six members of the Board of Directors shall be elected as follows: two to serve three years; two to serve two years; and two to serve one year, and thereafter two Directors shall be elected at the annual meeting of the McMinn-Meigs Association of Baptists, Inc. to serve three years. Vacancies created by death, resignation or removal from the Associational territory shall be filled at the next annual meeting following the creation of such vacancy by election of a Director to serve the unexpired term. Any person having served on the Board of Directors for a period of three years shall be eligible for re-election after a period of one year.

Section 4: The duty of the Board of Directors shall be to represent the Association in all legal matters and in such other matters as the Association or Executive Board directs, particularly as the real property owned by the Association, protecting the Association, where any process of law is required. Said Board may take such action as to the property holdings of the Association in the interim between the annual meetings, as the Board's discretion may be required or seem necessary or

advisable, except that said Board may not take any action in direct conflict with the policy or direction of the Association or Executive Committee. The moderator of the Association shall serve as President of the Board.

Article X – Committees and Functional Directors

Section 1: The Association shall also maintain the following Standing Committees and Functional Directors, categorized by function as Administrative, Ministry/Missions/Evangelism and Education/Resources as follows:

- A. **ADMINISTRATIVE:** Committee on Committees, Credentials Committee, Executive Committee, Nominating Committee, Personnel Committee, Property and Grounds Committee, Stewardship Committee and Resolutions/Bylaw Director.
- B. **MINISTRY/MISSIONS/EVANGELISM:** Evangelism Committee, Missions Committee, Christian Builders Director, Prayer Ministry Director and WMU Director.
- C. **EDUCATION/RESOURCES:** Media Library Director, Christian Education Director, VBS Director, Bible Drill Director, Seminary Extension Director and Baptist Collegiate Ministries (BCM) Director.

Section 2: The Committee on Committees shall be composed of three persons. The duties of this Committee shall be to recommend for election, at the following Annual Meeting, the members of the Standing Committees named in Article X, Section 1, with the exception of the Committee on Committees.

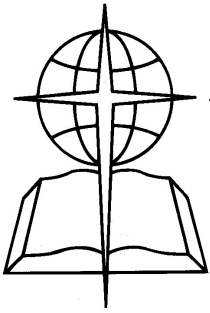
Section 3: Each of said standing committees, with the exception of the Committee on Committees, shall be composed of not less than three but not more than nine members. Members of these committees shall be rotating members and shall be selected from the membership of those churches affiliated with the Association, and shall be subject to reappointment, provided that in no case shall any person serve on the same committee longer than three years in succession, and provided that no person shall serve concurrently on more than two committees, except ex-officio members of all standing committees, including the Committee on Committees.

Article XI – Parliamentary Authority

The parliamentary authority of the McMinn-Meigs Association of Baptists, Inc. shall be the rules contained in the current edition of Roberts Rules of Order newly revised in all matters that are not consistent with these Bylaws and any special rules of order the Association may adopt.

Article XII – Amendments

These By-laws may be amended at any annual meeting, two-thirds of the members present, and voting, concurring providing at least 14 days written notice has been given to the member churches.

Officer, Organization Director and Committee Procedures

The following is information regarding the officers and standing committees of the McMinn-Meigs Association of Baptists, Inc.:

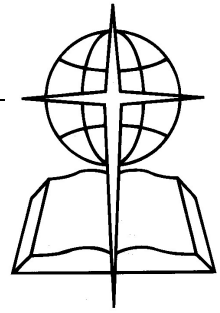
1. Officers are elected on an annual basis and all, except the Moderator and Associate Moderator, may succeed themselves on an annual basis.
2. The Nominating Committee of the Association shall recommend a list of officers and members of the Committee on Committees to the Executive Committee for approval at their third quarterly (July) meeting.
3. All officers and the nominated Committee on Committees shall assume their duties following the next Annual Meeting. However they can, between the Executive Committee July Meeting and the Annual Meeting, recommend, to the Committee on Committees, names of people to serve with them in their area of responsibility.
4. The Nominating Committee shall identify one person for the office of Moderator and one person for the office of Associate Moderator to be recommended for election at the annual meeting. The floor shall be open for additional nominees for the offices of Moderator and/or Associate Moderator, during the annual meeting. The Moderator and Associate Moderator shall assume their duties immediately following the conclusion of the Annual Meeting at which they are elected.
5. The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee and the Committee on Committees.
6. Association organizations and committees named herein shall make written and/or verbal reports to the regular meetings of the Executive Committee and the Association Annual Meeting. The Executive Committee shall exercise authority over these organizations and committees only to the extent of determining whether they are working within the bounds of organizational structure of the Association.

Association Officers and Organization Directors

The following is a description of the duties of the Association officers and organization directors. These Officers and directors are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

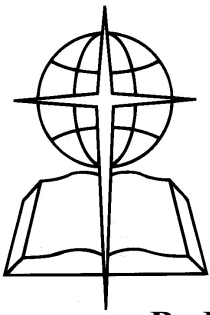
1. **Director of Missions** – The Director of Missions (DoM) is one of five paid employees of the Association (DoM, Secretary, BCM director, camp Director, and Caretaker) and has the responsibility for giving general direction to the paid staff and volunteer leadership of the Association. He is to serve as an ex-officio member of all committees, giving direction as needed and necessary, train the Association leadership in regard to their duties as a committee or organization and help to cast a vision as to the future direction of the Association. A more extensive list of ministry duties can be found in the Job Description Section of the Association Policy Manual.

2. **Moderator** – The Moderator shall preside at all meetings of the Association and shall serve as ex-officio member of all committees and organizations of the Association. The Moderator shall appoint a parliamentarian at any business meeting where the Bylaws Director is absent, and attend to such other duties as the office may require. The Moderator shall work closely with the Director of Missions in all matters of business and future plans (see Association By-laws Article VIII, Section 1).
3. **Associate Moderator** – The Associate Moderator shall be available to assume the duties of Moderator at any time the Moderator cannot fulfill said duties. He also shall serve as ex-officio member of all committees and organizations of the Association (see Association By-laws Article VIII, Section 1).
4. **Association Clerk/ Financial Secretary/Treasurer** – This person shall be a full-time employee of the association serving under the direct supervision of the Director of Missions. She/he shall be responsible for all duties as assigned and shall also serve as office receptionist. She/he shall also serve as the Association Clerk and be an ex-officio member of the Executive Committee and other organizations and committees as is necessary for her/him to attend. She/he shall be responsible for taking minutes (or making sure someone is present to fulfill that duty) at all Executive Committee meetings and at the Annual Meeting of the Association transcribing and distributing such to the proper persons. She/he is charged with maintaining accurate financial records and reporting. This person shall also serve as ex-officio member of the Stewardship Committee. See Job Descriptions for a more extensive detail of duties.
5. **Camp Cherokee Director** – shall have the responsibility of giving overall direction to the operation of the camp. This person shall keep the Association informed of the needs, schedule and vision for the camp. This person shall work closely with Camp Cherokee Committee in developing a maintenance schedule, usage schedule, fund raising system, and developing a vision for the camp. This person shall work closely with the Director of Missions and other key leaders keeping people informed about the ministry of the camp. This is a paid position (part time).
6. **Resolutions/Bylaws Director** – has the responsibility to oversee the Association Bylaws, proposing amendments as deemed necessary and preparing resolutions for association adoption as appropriate. The Director shall enlist other association members to serve as a committee as necessary for the fulfillment of this responsibility. This individual shall serve as the Association Parliamentarian for all Association meetings.
7. **The Board of Directors** – shall serve as the trustees (legal agents) for the Incorporated Association. This board is composed of nine members, six of which are elected annually on a rotating basis (two elected each year) at the Association Annual meeting. The other three members are the Moderator, Associate Moderator and Treasurer. The Director of Missions shall serve as ex-officio member.
8. **Stewardship Director**—shall be the chairman of the Stewardship Committee and shall give direction to the Association’s stewardship of that which is received from our churches and other sources. This person and the committee shall also be available to our churches to help them with any stewardship needs they might have (developing a budget, organizing a stewardship campaign and other stewardship related matters as requested).

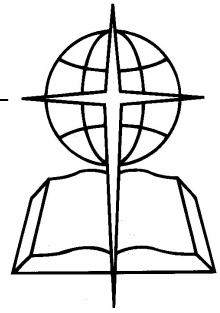

B. MINISTRY/MISSIONS/EVANGELISM

9. **Evangelism Director** – shall serve as chairman of the Evangelism Committee. Along with the committee this person shall work to keep the Association focused on the main thing, reaching people with the Gospel of Christ. This person and the committee shall encourage our churches, through a variety of means, to be evangelistic in seeking to reach their community and beyond. They shall be available to our churches to assist them in developing ministries that are evangelistic in focus that they might be more effective in their outreach efforts. They shall also be charged with the development and implementation of an annual Association-wide Evangelism Rally.
10. **Missions Director** – shall serve as the chairman of the Missions Committee and shall lead this committee in the responsibility for the development of the mission strategy for the Association.
11. **Woman’s Missionary Union (WMU) Director** – shall give general overall direction to the ministry of the WMU of the Association. She shall lead the WMU Council in planning various ministry/mission related events and shall, along with her leaders, be available to our churches to help them develop and/or strengthen their church’s WMU ministry. She and her team shall also keep the Association focused on missions through continuous mission education of children and adults. She shall work with the Director of Missions and the Association Missions Committee in casting a continuous mission involvement vision before the Association.
12. **Prayer Ministry Director** – shall, in conjunction with the Association Prayer Council, be responsible for developing an overall ministry of prayer for the Association. Through encouragement and hands on leadership this person is available to our churches to assist them in establishing an ongoing prayer ministry in their church. This person would, when needed, form ad hoc committees to address special prayer needs as they arise.
13. **Christian Builders Director** – shall serve as chairman of the Christian Builders Committee, coordinating the activities and projects of this committee, leading in outreach from our association to individuals and groups where the Christian Builders can minister through the use of their construction skills.

C. EDUCATION/RESOURCES

14. **Media Library Director** – shall be responsible for maintaining and updating the Media/Resource Center at the Association Baptist Center and shall be available to our churches to help them develop and/or strengthen their existing Media ministry.
15. **Christian Education Director** - shall be responsible for keeping our churches informed of the current trends in Sunday School ministry through correspondence, meetings and other means. This person shall also develop a team of leaders that would be available to go to churches to assist them in all areas of Sunday School ministry. Additionally, shall be responsible for keeping our churches informed of the latest trends in the area of Discipleship Training. This person shall also build a team of age group leaders specifically focused on leadership development in the area of Discipleship Training. This person and his/her team of leaders should be available to go to churches to help them develop and/or strengthen their Discipleship ministry. Further, this person shall oversee all areas of continuing education provided in and through the Association.

16. **Vacation Bible School Director(s)** – shall be responsible for organizing and coordinating the annual Association VBS Training Clinic. The Director(s) shall organize their leadership team and assure they are properly trained for the performance of their duties. The VBS Director(s) shall be available to serve as VBS consultants for the Association churches as requested.
17. **Bible Drill Director** – shall coordinate all events related to the Association Bible Drill Ministry. This person shall set a date, secure a location, contact participating churches, secure judges and callers for the Association event. This person shall do everything possible to get the word about Bible Drill to our churches and encourage them to provide the opportunity for their children and youth to be participants.
18. **Seminary Extension Director** – The Director of Missions shall serve as the Seminary Extension Director. He shall employ a teacher who has the responsibility of teaching two to three classes per year, recruiting students and helping them to set the curriculum for the year. This person is paid a fee per class taught.
19. **Baptist Collegiate Ministries (BCM) Director – Baptist Collegiate Ministries (BCM) Director** – receives a small stipend from the Association and shall be responsible for coordinating the ministry of the BCM ministry at Tennessee Wesleyan College in Athens, TN. This individual shall be employed and paid, in addition to the stipend mentioned above, by the Association with funds received from the Tennessee Baptist Convention and will function under the direction and supervision of the Association. Should the funds cease to be provided by the Tennessee Baptist Convention, the position will be terminated.

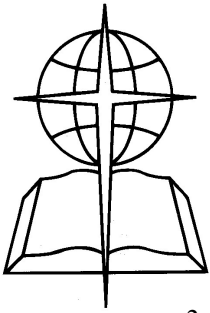
ASSOCIATION COMMITTEES

DESCRIPTION OF DUTIES AND COMMITTEE COMPOSITION

The following is the list of Association Standing Committees and their duties and composition. These Committees are grouped according to the major categories of ministry of the Association.

A. ADMINISTRATIVE

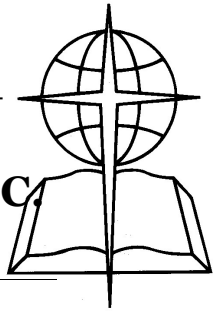
1. **Committee on Committees** – The Committee on Committees shall have the responsibility of recommending people to serve on the various standing and special committees of the Association, with the exception of the Executive Committee. Members of the Committee on Committees shall serve for one year only and may not serve consecutive terms.
2. **Credentials Committee** – shall receive and consider all applications from churches seeking membership in the Association. They shall study carefully the doctrines, practices and organization of each church seeking membership. They shall determine if said churches are in good standing with their sister churches. Their findings shall be conveyed to the Association at its next annual meeting from the time of application. It shall also be the responsibility of this committee to visit and advise any church of the Association which is reported to have departed from the doctrines and practices of the Association as set forth under Article II and III of the By-laws of this Association. Their findings and recommendations shall be reported at the next annual meeting of the Association. This rotating committee shall be composed of three members.

3. **Executive Committee** – shall consist of the following: one lay member from each member church; the Director of Missions, all organizations directors and committee chairmen and all Pastors of member churches. The Moderator, Associate Moderator, Clerk and Treasurer shall be ex-officio members of the Executive Committee. The committee shall meet quarterly at the Baptist Center, 350 N. Congress Parkway, Athens, Tennessee, or at another location as determined. The annual meeting of the Association shall be considered as the fourth quarter meeting of the Executive Committee. The Moderator has the discretion to call special meetings of the Executive Committee, as needed. Twenty members representing a minimum of 10 churches of the Executive Committee present and voting shall constitute a quorum. The Executive Committee shall be charged with the care of the interests of the Association in the interim between annual meetings. Other duties of the Executive Committee can be found in Article IX Sections 1-5 of the Association By-laws. The following shall be considered the guidelines for the conducting of Association Executive Committee and Annual meetings:
 - 1) A place shall be made on the Order of Business of the Executive Committee and Association Annual Meeting for miscellaneous business.
 - 2) One sermon shall be provided at each Association Annual Meeting
 - 3) The Moderator shall take the chair at the time to which the Association stood adjourned. The Executive Committee and Annual Meetings shall be opened and closed with prayer.
 - 4) The Moderator shall preside over the deliberations of the body, and see that good order is preserved, calling to order if necessary, and reminding members of their duty.
 - 5) Any member wishing to address the Association shall rise in his/her place, and address the Moderator. If more than one seems to address him at one time, he shall name the member to occupy the floor.
 - 6) The Moderator shall decide points of order, subject to an appeal from his decision to the Association. He shall have the preference to speak or explain when an appeal is taken from his decision.
 - 7) Any member may call for a point of order, and the member so-called shall take his seat until the one who made the call shall have time to make their point clear and distinct, and then shall be open for debates and explanations. No person shall speak more than once to any point of order except by leave of the association.
 - 8) The Moderator may name any member to fill the chair, but such substitutions shall not extend beyond adjournment; no motion shall claim his attention unless it is seconded, or shall be open for discussion until formally announced by him.
 - 9) The order of business of the Association shall be such as shall be adopted from time to time by the Association, and shall be subject to change or amendment at the pleasure of the Association.
4. **Nominating Committee** - Shall present, at the July meeting of the Executive Committee, nominations for the Board of Directors and Association officers (see Association Bylaws, Article IX, Section 1) and the Committee on Committees. This committee shall also

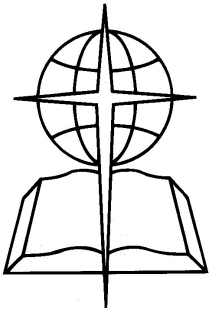

present, at the annual meeting, one nomination for the position of Moderator and one nomination for the position of Associate Moderator for election at the annual meeting. This rotating committee shall be composed of three members.

5. **Personnel Committee** – shall recommend staff personnel to fill vacancies occurring during the Association year, and recommend a person or persons to be added to the present staff, at such time as the Association may direct additional personnel to be employed. The committee shall have the power to recommend salaries, define vacations, hear grievances, act on fringe benefits, accept resignations and define the duties of employees. This rotating committee shall be composed of three members.
6. **Property and Grounds Committee** – shall be responsible for maintaining in good repair all equipment, buildings and properties of the Association, except Camp Cherokee, which shall be under the supervision of the Camp Cherokee Committee. This rotating committee shall be composed of three members.
7. **Stewardship Committee** – shall prepare annually a proposed budget for the Association and present such to the annual meeting for adoption. They shall be available to our churches to help them develop methods of supporting the budget. They shall consider all matters of finances referred to it by the Association, Board of Directors and the Executive Committee. They shall also give general supervision to the entire Association finance program, including current operational expenses, financial obligations assumed by the Association and planning and direction in regard to all capital needs and capital investments of the Association. The Treasurer shall be an ex-officio member of this committee. They shall be responsible for auditing all financial records of the Association and obtaining periodic independent audits. This rotating committee shall be composed of six members with the Stewardship Director serving as chairman.

B. MINISTRY/MISSIONS/EVANGELISM

8. **Evangelism Committee** – shall be charged with the responsibility of motivating and encouraging our churches in the area of evangelism. This is done by providing opportunities for our churches to learn of new methods in the area of evangelistic outreach, providing training sessions, organizing and conducting an annual evangelism conference, crusades and encouraging churches to reach new people and bring them into the church through baptism. This rotating committee shall be composed of three members with the Evangelism Director serving as Chairman.
9. **Missions Committee** – shall have the responsibility for the development of the mission strategy for the Association. They shall look at the various needs that exist in the area and develop ministries to meet those needs. They shall also focus on other mission opportunities outside the Association determining the direction the Association will take in the area of International and North American mission volunteerism. Determine the local ministries that the Association needs to develop or support and lead our churches and individuals to be involved. Determine methods that can be used to support and encourage continuing mission education in our churches. This rotating committee shall be composed of six-nine members with the Director of Missions, Moderator, Associate Moderator, and WMU Director serving as ex-officio members.
10. **Christian Builders Committee** – shall have the responsibility to answer the call of individuals and groups where the Christian Builders can minister through the use of their



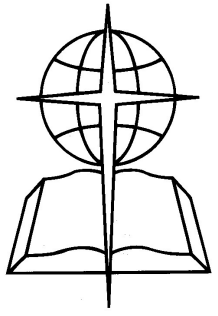

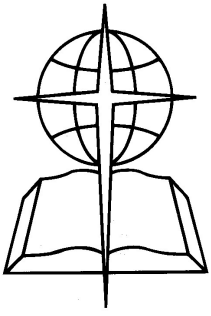

construction skills. This committee shall consist of six to nine members recommended by the Christian Builders Director who shall serve as Chairman of this committee.

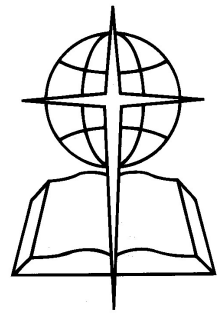
C. EDUCATION/RESOURCES
